A copy of the return is distributed to each board member prior to filing the return. A period of review and opportunity for questions is allowed.

Form 990, Part VI, Line 12c - Explanation of Monitoring and Enforcement of Conflicts

Each board member and key staff is to annually disclose any preceived conflict of interest to the Director or if he or she is the one with the conflict, then to the Chairman of the board, who shall bring these matters to the attention of the Board. The Board shall then determine whether a conflict exists and is material, and in the presence of an existing material conflict, whether the contemplated transaction may be authorized as just, fair, and reasonable as to the organization. The decisions on these matters are the sole discretion of the Board. The Board's first concern must be the welfare of the organization and the advancement of its purpose.
